Goals and Goal

Benchmarks:• Ease the conception and implementation of Unit tests for developers by providing an easy to find collection of existing important information concerning unit tests in ILIAS.

Benchmark

 Having one single source in the ILIAS repo containing or pointing to all relevant information, guidelines and examples existing in ILIAS.

Deliverables:

- PR including the tests/README.md containing all gathered information concerning Unit tests in ILIAS and/or links to further sources or documents presenting this information. This may also contain links to external sources (e.g. the PHPUnit documentation).
- Set of guidelines in the tests/README.md files containing all already agreed upon guidelines concerning unit tests.
- Set of examples in the tests/README.md which shows how unit tests for common scenarios in ILIAS can be devised (if possible pointers to existing tests should be provided). The set of scenarios covered by the example will result of the set of scenarios found during research for which already tests exist.
- FAQ containing at least answers to the following question (the answer may also be, that this question has no final answer yet):
 - O What needs to be tested?



- How is a local test environment set up?
- How do I start unit tests for ILIAS in PHPStorms and Console?
- O Where do I put my unit tests?
- What is the ILIAS CI-Server and how can I benefit from it in terms of unit tests?
- What do I need to consider concerning tests before pushing code to the ILIAS repo?
- Presentation of the tests/README.md in the JF. If the research
 of existing guidelines for ILIAS unit tests revealed contradictory
 guidelines or guidelines that have been implicit up to this point
 they must clearly be outlined in the discussion and resolved.
- Removal/refactoring of other sources concerning unit/tests in ILIAS (e.g. Dev-Guide) by linking to the new source in tests/README.md.

General Conditions:

The following steps will have to be completed:

- Discussion of a first proposal of the tests/README.md with the TB.
- Revision of the tests/README.md according the feedback of the TB.
- Discussion of the proposal of the tests/README.md with the JF.
- Revision of the tests/README.md according the feedback of the JF.
- Merge of the test/README.md after the final approval of any member of the TB.
- Removal/Refactoring of former sources for information of unit tests on ilias.de.
